Trustee Plock clarified for the public that the Levy is a 4% increase in total dollars but an 8% decrease in the overall tax rate of individual properties, making it clear to the public that the tax rate is going down, not up. President Gustafson stated the overall amount for the Tax Levy for Village of Roscoe is \$1,760,026.00

 Discussion and Approval of Expenditures related to the Village Holiday Decorations at Bridge & Main

President Gustafson and Administrator Kurlinkus provided a summary of the options for the Christmas Trees.

The Village is currently obtaining quotes for a municipal Christmas tree to serve as a centerpiece for our holiday celebrations. Options under consideration include purchasing and installing a live or artificial tree, hiring a company to manage the tree's lighting, or renting a pre-lit RGB tree for approximately \$8,000. Additionally, the Village must decide whether to utilize Public Works staff for the tree's installation and lighting, which may impact resources for other end-of-season operations or to contract with a professional company to lessen the burden on Village resources. Staff seeks direction from the Village Board regarding the preferred approach and an appropriate budget allocation for this year's holiday display.

Option 1 is renting an RBG tree as well as lighting the 20 4' trees. Option 2 is lighting the existing living tree on that corner as well as lighting the 20 4'trees.

President Gustafson confirmed with board that the direction is to decorate what is there for this year.

NEW BUSINESS (First reading or suspend rules)

11. Approval of **Ordinance 2024-12**, annexing **two contiguous parcels** located at **13000 and 13019 North 2nd Street.** (PIN 04-21-151-004 & 04-21-151-005) into the Village of Roscoe and designating the zoning of such parcels as Village of Roscoe **IL - Light Industrial**

Administrator Kurlinkus, summarized that the applicant is requesting a rezoning of two parcels located at 13000 and 13019 N 2nd Street. The parcels are approximately 8.3 acres in size (2.92 and 5.38 acres individually). There is an existing industrial office building on the southernmost parcel that is approximately 8,100 square feet in area. The southernmost parcel also has an existing outbuilding/shed at the edge of its parking lot that is approximately 600 square feet in size. The northernmost parcel is currently vacant except for a billboard near the right of way.

The parcels are currently not annexed into the Village, but are seeking an annexation petition to

file with Winnebago County to officially join within the Village's borders. Under Section 15-389, newly annexed land into the Village is automatically designated as an Urban Transition (UT) zoning district. This is a relatively limiting zoning district and is meant more as a holding place for parcels of land that have not yet seen development.

Once completed they will need to go to the suburbs to take the testing/certification through the FAA and then there will be 5 certified pilots/officers. The idea is to have someone who can operate the drone on each shift.

Troy of Public Works stated that Christmas decorations will be going up this week.

Brandon provided an update on the three designs projects:

Love Road & Willowbrook Road are completed and have been sent to all agencies in June. They are unfunded projects and on the review list. Currently no major update.

Main Street Project design plans on hold, currently not advancing those but the pedestrian bridge is being advanced. A bridge bat assessment will need to be done, which is part of the environmental plan.
