

**VILLAGE OF ROSCOE  
ORDINANCE NO. 2024-12**

**AN ORDINANCE AMENDING CHAPTER 114 OF THE VILLAGE OF ROSCOE CODE OF ORDINANCES CONCERNING THE REGULATION OF LICENSED LIQUOR ESTABLISHMENTS WITHIN THE VILLAGE OF ROSCOE (INCREASING MAXIMUM CLASS “CT” & REDUCING MAXIMUM CLASS “BP”)**

**WHEREAS**, Chapter 114, Article III of the Village of Roscoe’s Code of Ordinances defines the classification, scope and fees for liquor licenses available in the Village; and

**WHEREAS**, the Village of Roscoe desires to amend §11-348 by **increasing** the total number of **Class “CT”** Liquor Licenses authorized and available for issuance by the Village of Roscoe; and

**WHEREAS**, the Village of Roscoe desires to amend §11-347 by **decreasing** the total number of **Class “BP”** Liquor Licenses authorized and available for issuance by the Village of Roscoe; and

**WHEREAS**, this Ordinance is not intended to deprive any currently licensed liquor establishment from maintaining their current liquor license classifications, nor from restricting those establishments from renewing their licenses pursuant to the regulations set forth under the Village of Roscoe Code of Ordinances; and

**WHEREAS**, the Village of Roscoe is authorized and empowered by statute to amend and enforce the provisions of this Ordinance.

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ROSCOE, WINNEBAGO COUNTY, ILLINOIS AS FOLLOWS:**

**Section 1.** The foregoing recitals are incorporated herein as findings of the Village of Roscoe Board of Trustees.

**Section 2.** That section **§11-348(d)** of the Village of Roscoe Code of Ordinances is hereby amended to reflect as follows:

*“Number authorized.* The number of **Class CT** licenses which may be in force and effect at any given time shall be limited to ~~one~~ **two**.”

**Section 3.** That section **§11-347(d)** of the Village of Roscoe Code of Ordinances is hereby amended to reflect as follows:

*“Number authorized.* The number of **Class BP** licenses which may be in force and effect at any given time shall be limited to ~~one~~ **zero**.”

**Section 4.** After review of its duly filed application to the Village of Roscoe, and the review and recommendation for approval by the Village of Roscoe Liquor Commission, a Class “CT” License is hereby granted to: **Hoffman House of East Rockford, Inc. DBA Firehouse Pub.**

**Section 5.** Any portion of any other ordinance in conflict with this ordinance is hereby expressly repealed to the extent of the conflict.

**Section 6.** All other portions of the Code of Ordinances of the Village of Roscoe shall remain in full force and effect.

**Section 7.** This Ordinance shall be in full force and effect as of **January 1, 2025**, and after its passage, approval, and publication in pamphlet form as provided by law.
