THE APPROVAL AND EXECUTION OF A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE ILLINOIS STATE POLICE FOR TRANSMITTAL, RECEIVING AND STORAGE OF LEADS, NCIC AND SOS INFORMATION AND DATA

WHEREAS, WHEREAS, the President and Board of Trustees of the Village of Roscoe (the "Village Board"), operating as a home rule municipality, have all of the powers and authority granted to such municipalities pursuant to Article VII (Local Government), Sections 6 (Powers of Home Rule Units) and 10(a) (Intergovernmental Cooperation) of the Illinois Constitution of 1970, including the right to exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the President and Board of Trustees of the Village of Roscoe ("Village") and the Illinois State Police have jointly determined that it is in the best interests of the Village and its residents for the Roscoe Police Department and the Illinois State Police to agree on the transmittal, receiving and storage of Law Enforcement Agencies Data System ("LEADS"), National Crime Information Center ("NCIC") and Secretary of State ("SOS") information and data between the two agencies; and

WHEREAS, the Village Board and the Illinois State Police desire to enter into a Memorandum of Understanding ("MOU") relative to the performance of the transmittal, receiving and storage of LEADS, NCIC and SOS information and data between the two agencies. The MOU contains all of the terms, conditions and obligations that the parties will be responsible for as part of their participation in the MOU. A copy of the MOU is attached hereto as Exhibit "A" and made a part hereof; and

WHEREAS, pursuant to its home rule powers and contracting authority provided by Article VII (Local Government), Sections 6 {Powers of Home Rule Units) and IO(a) (Intergovernmental Cooperation) of the Illinois Constitution of 1970, as well as the Illinois Intergovernmental Cooperation Act (5 ILCS 220), the President and Board of Trustees of the Village of Roscoe have the authority to ratify the approval and execution of the attached MOU by Roscoe Police Chief Elijah Willis, and find that entering into the MOU is in the best interests of the Village, its residents, business owners and the public.

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ROSCOE, WINNEBAGO COUNTY, ILLINOIS THAT:

SECTION 1: Each of the findings above is incorporated by reference into this Section 1 and made a part hereof as material and operative provisions of this Resolution.

SECTION 2: The President and Board of Trustees of the Village of Roscoe ratify the approval and execution of the MOU by Chief of Police, attached hereto as Exhibit "A" and made

a part hereof. Further, the Board of Trustees of the Village authorize and direct the Village President, the Police Chief and the Village Attorney, or their designees, to execute the MOU and to execute and deliver all other instruments and documents to the Illinois State Police that are necessary to fulfill the Village's obligations under the MOU.

SECTION 3: This Resolution shall be effective immediately upon its passage and approval, or as otherwise provided by law.
