## <u>ITEM</u>

2023-47 - Resolution to adopt the 2024 Budget.

## BACKGROUND

City Council passed resolution 2023-47 to adopt the 2024 budget at the October 17, 2023 regular meeting. However, a budget hearing which was opened at the October 3 meeting and continued to the October 17 was not closed prior to this adoption; thus the vote needs to be retaken after closing the budget hearing which was re-noticed.

## FISCAL NOTE

As discussed in detail during previous meeting, The 2024 budget is \$49,493,456 for all funds. The budget is supported by \$49,493,456 in anticipated 2024 revenue (including debt proceeds for the fire house) and a potential use of fund balance reserves in the amount of \$4,140,233 resulting in a balanced budget.

#### STAFF RECOMMENDATION

After reopening the budget hearing continued from October 3 and giving due consideration to citizen comments, it is recommended that the public hearing be closed, and that the Council adopt the 2024 budget and appropriation resolution.

## SUGGESTED MOTION

A council person should make a motion to adopt resolution 2023-47 establishing a budget for the calendar year 2024.

#### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SALIDA, COLORADO, SUMMARIZING REVENUES AND EXPENDITURES FOR EACH FUND AND ADOPTING A BUDGET FOR THE CALENDAR YEAR BEGINNING ON THE FIRST DAY OF JANUARY 2024 AND ENDING ON THE LAST DAY OF DECEMBER 2024

**WHEREAS**, The City Council of the City of Salida appointed the City Administrator to prepare and submit a proposed budget to said governing body at the proper time; and

**WHEREAS**, on September 18, 2023, the Interim City Administrator submitted a proposed budget to the City Council for its consideration; and

**WHEREAS**, upon due and proper notice, published or posted in accordance with applicable law, said proposed budget was open for inspection and a public hearing held on October 3, 2023 and interested taxpayers were given the opportunity to file or register any objections to said budget.
