## BACKGROUND

The Department of Parks and Recreation enters into many agreements with other organizations and contractors to hold events, complete work, or offer services. Based on community and council input, the Department included a splashpad in the 2022 budget. Council approved \$350,000 for the project in the 32-32-54-6077-3 line. The Department of P&R worked with a designer and created a concept for the splashpad that was used to creat a request for proposals (RFP) to build the spalshpad. Below are the results of the recent Centennial Park Splash pad RFP.


