## <u>ITEM</u>

Resolution 2022-18 – Approving A Citizen Appointment to the Harriet Alexander Field – Salida Airport Advisory Board

## BACKGROUND

As you are aware, the City of Salida owns half of Harriet Alexander Field in conjunction with Chaffee County. As such, the two bodies agreed to appoint an Advisory Board to recommend planning, operations, maintenance, and capital improvements for the facility. Current Board members include Jim Dickson and Rob Dubin, and Councilmember Justin Critelli has represented the City Council as official liaison.

A vacant position exists on the Advisory Board for a position to be filled to represent the Salida City Council. Terms are recommended to be up to 3 years in duration. There is currently one community member – James Barker – that has expressed interest in joining the Board to represent the Salida City Council's interest; Mr. Barker's background information is attached. The Advisory Board has expressed support for Mr. Barker's appointment to the position.

Staff recommends that the City Council appoint James Barker to a term on the Harriet Alexander Field – Salida Airport Advisory Board as determined by the City Council.

**WHEREAS**, the City of Salida, Colorado ("City") is a statutory city, duly organized and existing under the laws of the State of Colorado; and

**WHEREAS**, the City Council appreciates the service these members of the community have devoted to bettering Salida and Chaffee County through participation in the Harriet Alexander Field – Salida Airport Advisory Board; and

**WHEREAS**, in accordance with Section 2-7-10 of the Salida Municipal Code, the City Council shall confirm the appointments by majority vote.

NOW, THEREFORE, IT IS RESOLVED BY THE CITY COUNCIL OF THE CITY OF SALIDA, COLORADO, THAT:

**Section 1.** The Salida City Council incorporates the foregoing recitals as its conclusions, facts, determinations and findings.

**Section 2.** The Salida City Council hereby appoints James Barker as a member of the Advisory Board for Harriet Alexander Field – Salida Airport; term to expire January 1, 2024.
