The Salida Moth is a fundraiser for A Church and Khen. This will be our second year. The first year we had 3 different events with 5 performances in total.

We began this storytelling event after COVID with the intention of bringing people together through shared stories and experiences. We base our event off of the original idea of the Moth by sharing original, true stories told by the storyteller.

The Moth originally began in 1997 by poet and novelist George Dawes Green. George and his friends would gather to share stories on his front porch and noticed how the moths were drawn to the light. The idea of sharing true stories became the glue of NPR's Moth radio hour, a weekly series featuring true stories told live without scripts, notes, props or accompaniment. This is the 26th year of this radio series.

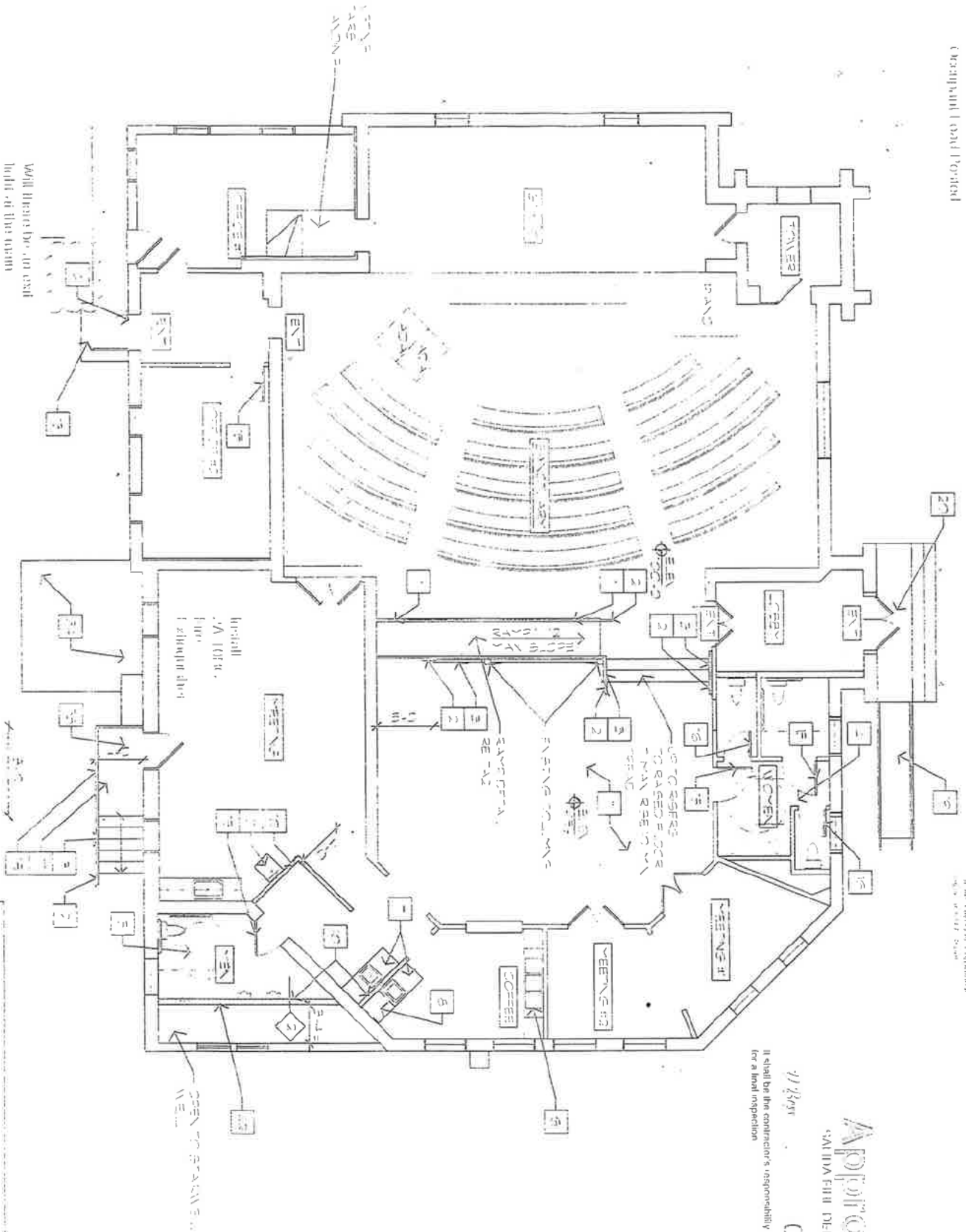
