Resolution 2022 -57 Citizen Appointments to the Planning Commission

BACKGROUND

The Planning Commission is made up of seven regular members and two alternate members. Regular member Dave Haynes resigned earlier this year and Alternate member Laura Atwood moved outside of the City and had to resign her position as alternate.

On February 5, 2019 Commissioner Kriebel was appointed as a regular member to fill a vacated seat with a term expiring on January 1, 2023. With his term expiring, Commissioner Kriebel has indicated that he would like to serve another four year term. Alternate Member, Aaron Derwingson has indicated he would like the opportunity to move into the vacated regular seat.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SALIDA, COLORADO, APPROVING CITIZEN APPOINTMENTS TO THE PLANNING COMMISSION PURSUANT TO SECTION 2-7-10 OF THE SALIDA MUNICIPAL CODE.

WHEREAS, in accordance with Section 2-7-10 of the Salida Municipal Code ("SMC"), the City Council shall select and appoint person(s) to serve as members of the City of Salida Planning Commission; and

WHEREAS, Giff Kriebel's term will expire on January 1, 2023 and he wishes to serve another term on the Planning Commission; and

WHEREAS, there is one regular member vacancy on the Planning Commission and alternate member Aaron Derwingson has expressed a desire to be moved to the regular position; and

WHEREAS, there is one alternate member vacancy on the Planning Commission and after soliciting and interviewing candidates, the City Council wishes to fill these vacancies for prescribed terms; and

WHEREAS, the City Council appreciates the service these members of the community have devoted to bettering Salida through participation on the Planning Commission; and

WHEREAS, in accordance with Section 2-7-10 of the Salida Municipal Code ("SMC"), the City Council shall confirm the appointments by majority vote.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SALIDA, COLORADO THAT:

- 1. The City Council hereby appoints the following individuals to serve on the Planning Commission in the following capacity and term:
 - a. The City Council hereby re-appoints <u>Giff Kriebel</u> as a regular member of the Salida Planning Commission; term to expire January 01, 2027; and
 - b. The City Council hereby appoints <u>Aaron Derwingson</u> as a regular member of the Salida Planning Commission; term to expire March 21, 2024; and
 - c. The City Council hereby appoints ______ as an alternate member of the Salida Planning Commission; term to expire February 15, 2026.
