**BE IT ORDAINED** by the Mayor and City Council of the City of Sandwich, DeKalb and Kendall Counties, Illinois, **THAT:**

**AN ORDINANCE AMENDING CHAPTER 82 – “TRAFFIC AND VEHICLES,”  
ARTICLE II – “OPERATION OF VEHICLES,” DIVISION 3 – “THROUGH, ONE-WAY  
AND YIELD STREETS; STOP INTERSECTIONS,” SECTION 82-81 – “STOP  
STREETS.” OF THE CITY OF SANDWICH MUNICIPAL CODE**

shall be, and is hereby, adopted as follows:

Section 1.      BACKGROUND.

The City of Sandwich (“**City**”) has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs, and to review, interpret, and amend its ordinances, rules, and regulations. The City has determined that it is in the best interest of the City to amend its ordinances with regard to intersections designated as stop intersections within the City of Sandwich boundaries.

Section 2.      AMENDMENT.

A. Chapter 82 – “Traffic and Vehicles,” Article II – “Operation of Vehicles,” Division 3 – “Through, One-Way and Yield Streets; Stop Intersections,” Section 82-81 – “Stop Streets” of the City Code of Ordinances is hereby amended as follows (additions in **bold and underline**, deletions in **~~bold and strikethrough~~**):
