# JOINT COUNCIL/PLANNING COMMISSION WORK SESSION - 6:00 PM

1. Comprehensive Plan – Economic Opportunity Analysis work session

Attendance note: Planning Commission Chair Crosby and Commissioners Wegener and Ramseyer were present for the work session.

After introductory remarks from the Development Services Director, Beth Goodman with ECONW delivered a presentation on the Economic Opportunities Analysis (EOA) component of the Comprehensive Plan update. The draft EOA and presentation slides were included in the agenda packet.

Council discussion ensued on the following topics:

- Barriers to availability of industrial land, including slope and access challenges
- Possibilities for future UGB swaps
- The way in which the plan maps display industrial parcels that are partially vacant
- The need to ensure all land status information is up to date
- The need to perform analysis of the relative ease or difficulty of providing utility service to different parcels, and whether this should be a factor in the plan
- Discussion on work commuting data, and whether more attention should be paid to transportation connections to Portland, Gresham, and Beaverton (where many Sandy residents currently work)
- Limitations on development within the Bonneville Power Administration easement
- Discussion on the data impact of remote work; clarification on the accounting of location data for employees who work at home in Sandy for companies that are headquartered elsewhere
- Discussion of the potential, and the challenges involved, in rezoning properties from commercial to industrial
- Implications of State affordable housing legislation, and discussion of whether rezoning certain properties would be a beneficial action to take to retain local control
- Discussion of urban versus rural minimum wage thresholds, and whether they factor into data in the plan
- Discussion of whether the City's allowance of commercial uses on industrial land has affected metrics in the plan
- Discussion of whether the plan data accounts for parcels that have uses other than what is indicated by the zone

- Request for staff to provide information on how different zones and business types affect City revenue collection through property taxes and other mechanisms
- Staff will incorporate the Council's feedback into the draft plan

Following the discussion, the City Manger introduced the new Senior Planner to the Council.

This is Sandy Police's fourth accreditation.
