2. CBX Business IGA Revision

Staff provided details about the lottery project, including scope, costs and requirements for SandyNet to complete the project.

Staff explained the changes in the IGA revision to include a specific rate for the lottery connections as well as passive optical network (PON) service tier for half gigabit services that could be used to bring on other connections at each of the lottery sites.

3. Calix SmartHome

Staff presented the Calix SmartHome proposal and the board discussed and provided feedback. Interest was expressed by the board for the Protect IQ and Parental Controls, and concern was expressed for some of the newer offerings, particularly the HomeOffice IQ and downsides of using the SmartTown features.

Staff clarified pricing and budgeting questions, noting that funds would be available after the expiration of an existing Calix service that Staff did not intend on renewing.

4. Static IP Addresses

Staff explained a recent concern from a subscriber around the cost of static IP addresses for residential broadband service. The board discussed the pricing and offering of residential static IP addresses among the other Oregon municipal internet providers and identified no issues with the current offerings or price.
