2. The Board will review updated Park Rules and provide input.

Rochelle presents on changes to park rules. Rochelle explains we will present these suggestions to the lawyer for their review and final approval.

Rule 2- There was a request to add archery, however we later discovered this was already included in Rule 14.

Rule 7- A question was asked if Cannabis falls under smoking.

Rule 8- There's a clarifying question asked about how littering and normal park usage garbage falls under this rule.

Rule 10- Add exception for City Staff. The group asks about adding a note about fishing and spawn protection.

Rule 13- Add ODFW regulation note.

Rule 14- A question is asked if we can add a note about profanity in music. This will possibly be added to rule 11.

Rule 16- A question is asked if the Community Gardens need to be called out in this rule. Tiana clarifies the Community Gardens are a pesticide free zone.

Rule 17- A suggestion is made that art added should need to be approved by the Parks Director. Painted rocks were a topic during the discussion of this question. "Art" will be added under definitions.

Rule 19: This rule could have language added to apply to painted rocks.

Rule 25: Don would like some verbiage added that it's prohibited to block paths, trails, sidewalks, parking lots and spaces, and driveways without written permission.

A question is asked if we can list hate speech in the rules. P& R will check with legal.

Don asks about Golf being allowed.

P&R will bring back the updated rules at the next meeting for one final review.
