Hi Patrick,

Thanks for sending. I've been in contact with Jenny, and we went over everything, but I hadn't given her a formal approval yet. They have been given great info/requirements from last year's Fire Marshal and I didn't have additional concerns other than if they have food carts/trucks on Scales, they'll want to ensure that the fire suppression systems are up to date on their service.

Regarding the barriers...I believe she is planning on using the Type 3 barriers which will work and are relatively easy to move if we ever need to.

Also, I wanted to mention, when the fireworks tent is eventually set up in late June, we will be inspecting that to ensure it's in line with what they submitted to the Oregon State Fire Marshal.

Clackamas Fire is in approval of the 2024 Mt. Hood Farmers Market in Sandy.
