

**AMENDMENT TO THE INTER-LOCAL COOPERATION AGREEMENT BETWEEN
DENTON COUNTY AND THE CITY OF SANGER POLICE AND FIRE
DEPARTMENTS FOR THE USE OF THE DENTON COUNTY RADIO
COMMUNICATIONS SYSTEM**

This Amendment will go into effect on August 1, 2025 and run through the remainder the remainder of the 24-25FY, until September 30, 2025. The Inter-Local Agreement (“Agreement”) is entered into by and between the County of Denton, Texas (“the County”) and the City of Sanger, Texas, both entities being located in Denton County, Texas (collectively, the “Parties” or separately as a “Party”). The Parties execute this agreement as hereinafter provided, pursuant to the Texas Governmental Code, Chapter 791, known as the Inter-Local Cooperation Act:

WHEREAS, the City of Sanger Police and Fire Departments and Denton County executed the Interlocal Cooperation Agreement for use of the Denton County Radio Communications System on July 30, 2024 via Court Order #24-0616; and

WHEREAS, the City of Sanger notified the Denton County Sheriff’s Office in writing on June 24, 2025 the Police Department was in the process of purchasing thirty-five (35) Motorola handheld (only) radios which would require the terms of the remaining months within the current FY24-25 agreement to be amended; and

WHEREAS, the City of Sanger notified the Denton County Sheriff’s Office in writing on July 21, 2025 confirming the purchase of the Motorola handheld radios and providing the number of said radios that will be utilized and to be included within the contract, which in turn would require the terms of the remaining months within the current FY24-25 agreement be amended; and

WHEREAS, the City of Sanger and Denton County desire to Amend Exhibit B of the 24-25FY Interlocal Cooperation Agreement for the Use of the Denton County Radio Communications System with this Amendment.

NOW, THEREFORE, the County and the Agency agree to the Amendment pursuant to the terms and conditions outlined below:

1. The attached Amended Exhibit B is hereby added to the Interlocal Cooperation Agreement for the Use of the Denton County Radio Communications System and is to replace the current Exhibit B, 2024-25 Agency Payment Worksheet/Invoice for the City of Sanger Police Department.
 - a. Upon the request of the City of Sanger, the FY24-25 Radio Communications Contract, is being adjusted to reflect 25 Motorola Handheld radios at Tier 3 and 24 Non-Motorola In-Car radios at Tier 1 level for the remaining term of August 1, 2025 through September 30, 2025.
2. All other terms and conditions of the Agreement shall remain in full force and effect.
