RESOLUTION NO. 2026-07

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANGER, TEXAS, APPOINTING AND REAPPOINTING MEMBERS TO THE TO THE PARKS AND RECREATION / KEEP SANGER BEAUTIFUL BOARD; 4A INDUSTRIAL ECONOMIC DEVELOPMENT CORPORATION; AND 4B THE SANGER DEVELOPMENT CORPORATION, AUTHORIZING ITS EXECUTION, AND PROVIDING AN AUTHORIZING ITS EXECUTION, AND PROVIDING AN EFFECTIVE DATE.
