1. Bureau of Land Management Presentation and Updates. Jake Palma, Monticello Field Manager

Jake Palma, Monticello Field Manager for the Bureau of Land Management (BLM), has been attending meetings held with his leadership and county employees such as Nick Sandberg and

TJ Adair to improve communication with the BLM and the county commission. He mentioned the eight (8) interns that BLM has sponsored this year and the many projects they are involved in within the county. He mentioned the changes in the Bureau of Land Management federal environmental policies and their efforts to streamline permitting and other processes. The BLM is working on a drill pad up on Lightning Draw. The BLM is expanding the campground in Indian Creek, specifically the Hamburger Rock area. Jake mentioned the House on Fire hike is very popular, therefore, BLM has been improving access by graveling roads, adding parking spaces, and a bathroom facility. The Velvet-Wood mine has been approved using the emergency permitting procedures powers.

2. Presentation on a Bolder Way Forward Announcements. Susan R. Madsen

Debra, spokesperson for a Bolder Way Forward organization (USU), spoke of increasing safety for women and girls within the State of Utah. She stated the state has high rates of domestic violence, sexual assault, and child abuse. Debra spoke about the need to work together in an organization such as the Bolder Way Forward. Debra taught there are 18 spokes to the wheel, and all are counted and assessed each year. These "spokes" cover education, health & wellbeing, safety & security, workplace & community engagement. She believes that if men become greater allies, then women and families rise in stature and safety.

ReNee McDonald, the San Juan School District representative, is sponsoring "living room conversation" meetings throughout the county, where individuals can gather and discuss issues impacting their lives. The program is a grass roots organization and does not receive state, county, or city funding.

3. Parents Empowered Presentation. San Juan County Prevention, Action & Collaboration Coalition (SJCPAC). ReNee McDonald
