#### **COMMISSION REPORTS**

Commission Chair Harvey presented a ball cap to Commissioner Adams and a plastic bag to Commission Vice-Chair Stubbs (he received them while attending an economic mobility conference in Pennsylvania). He reported to the Utah Navajo Trust Fund committee a proposal to pave the Phillips Road, which is a 4–5-mile stretch. The road has become impassable for many drivers. He was hoping the county road department would bring their equipment down to pack down the materials donated by the Trust fund.

Commission Vice-Chair Stubbs reported she attended the Seven County hearing with the Supreme Court. An environmental group sued using NEPA, and the court upheld the NEPA rules. She also attended the Planning & Zoning Commission meeting.

Commissioner Adams asked Larry Ellertson (online) if he had any comments. There were questions and answers about the RECA bill and including the Monticello mill workers. Commissioner Adams will be attending the inauguration of President Trump on January 20, 2025. He has been introduced to the Utah Department of Transportation (UDOT) board; tomorrow he is on his way to the Four County meeting in Price and the UCIP meeting in Murray.
