



INTERLOCAL AGREEMENT BETWEEN BLANDING CITY AND SAN JUAN COUNTY FOR SUPPORT OF THE BLANDING SENIOR CITIZENS CENTER

This Agreement is made and entered into this _____, by and between **Blanding City**, a municipal corporation of the State of Utah, hereinafter referred to as "City," and **San Juan County**, a county government in the State of Utah, hereinafter referred to as "County."

RECITALS

WHEREAS, the Blanding Senior Citizens Center plays a vital role in providing essential services, social activities, and educational opportunities for the senior citizens of Blanding City; and

WHEREAS, both City and County have identified a need for additional funding to enhance the programs and classes offered at the Blanding Senior Citizens Center; and

WHEREAS, the Blanding City Council recognizes the importance of supporting the Senior Citizens Center in its efforts to improve the quality of life for the City's senior residents; and

WHEREAS, a \$2,000 donation from the City will enable the County to pay individuals to lead classes at the Blanding Senior Citizens Center, thereby allowing these individuals to be employed by the County and have better hours at the Blanding Senior Citizens Center; and

WHEREAS, this donation is intended to assist in ensuring that the Blanding Senior Citizens Center continues to offer valuable programs and services to senior citizens;

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, the parties agree as follows:

AGREEMENT TERMS

1. Donation

The City agrees to contribute **\$2,000** to the County, specifically designated for the Blanding Senior Citizens Center. These funds shall be used to support the funding of classes and related activities at the Center.

2. Use of Funds

The funds donated by the City shall be used by the County for the following purposes:

- To help with the offering of ongoing and possible new classes for center participants.
- To cover additional utility costs associated with the increased usage of the Center due to these activities.
- Any unused funds during the San Juan County Fiscal Year shall be transferred over to



the next fiscal year to be used for the same purpose stated above.

3. Budgetary Allocation

The City Council hereby authorizes the allocation of **\$2,000** in the City's budget to fulfill this commitment, beginning with the current 2025 fiscal year.

4. Term of Agreement

This Agreement shall commence on the date first above written and shall continue for one year. Based on Budgetary Allocation by the City, this agreement may be renewed with the County year over year.

5. Termination

Either party may terminate this Agreement for any reason by providing **30 days' written notice** to the other party. Upon termination, any remaining unspent funds provided under this Agreement shall be returned to the City.

6. Amendments

This Agreement may only be amended in writing and signed by authorized representatives of both parties.

7. Reporting

The required reporting from San Juan County to Blanding City can be made in writing to the Blanding City Manager with a simple explanation of how the funds were used to support the Blanding Senior Citizens Center. The purpose of reporting is to assure that positive outcomes are seen by the Senior Citizens Center Director and not to add burden in reporting.

8. Miscellaneous

- **Governing Law:** This Agreement shall be governed by and construed in accordance with the laws of the State of Utah.
- **Entire Agreement:** This Agreement contains the entire agreement between the parties and supersedes any prior agreements, written or oral
