BILLING DEPOSIT

There are a number of options available to you in lieu of this cash deposit. If you are interested in using one of these option, contact any consumer service representative at our office. If a bill deposit is required, it must either be paid along with the construction cost or if applicable, arrangements must be made prior to construction scheduling.

REQUIREMENTS TO BE COMPLETED BEFORE CONSTRUCTION SCHEDULING

1. Sign and return the EEA copy of the enclosed contract. Signatures on the contract need to match the names on the account as indicated on the top line of the contract. Keep the applicant copy for your records.
2. Sign and return one copy of the enclosed approval form sketch. You need to provide the contractor copy to the appropriate contractors doing trenching and wiring. Keep consumer copy for your records. *Has work for WO#289714 Combined on form*
3. Sign and return the enclosed easement form. This form requires that all signatures indicated on the form be provided and notarized. This form will be recorded as a public record. Keep the additional copy for your records.
4. Provide total amount as indicated above.
5. Sign, date and return Pole Release Form.
6. Other.

SERVICE AGREEMENT

After construction is completed by Empire Electric, you agree to pay the monthly base charge plus any taxes or fees specified in the applicable rate tariff, regardless of whether electric service is utilized. If electric service is utilized, energy and demand charges, as specified in the applicable rate tariff, shall also be paid.
