

## ORDINANCE NO. 12-04-2023

AN ORDINANCE UPDATING THE SANTAQUIN CITY WATER CONSERVATION PROVIDING FOR CODIFICATION, CORRECTION OF SCRIVENER'S ERRORS, SEVERABILITY, AND PROVIDING AN EFFECTIVE DATE DECEMBER 28, 2023.

WHEREAS, the adoption of a water conservation plan has been mandated by the State of Utah; and

WHEREAS, Santaquin City operates a culinary water system and a pressurized irrigation system; and

WHEREAS, the Santaquin City Council understands the pressing need to use water in a more efficient manner to allow for future sustained growth of the community; and

WHEREAS, City staff have caused a water conservation plan to be created in 2013 and updated in 2018 and desires now to update said plan in 2023; and

WHEREAS, the City Council of Santaquin City desires to update the Santaquin City Water Conservation Plan Ordinance for the health, safety and welfare of the citizens of Santaquin City and update the ordinance into the Santaquin City Code; and

NOW, THEREFORE, BE IT ORDAINED by the City Council of Santaquin City, Utah County, Utah, as follows:

### SECTION 1. Amendment of Water Conservation Plan

The Santaquin City Water Conservation Plan is hereby amended as attached.

### SECTION II. Codification Inclusion in the Code and Scrivener's Errors

It is the intent of the City Council that the provisions of this ordinance be made part of the City Code as adopted, that sections of this ordinance may be re-numbered or re-fettered, that the word ordinance may be changed to section, chapter, or other such appropriate word or phrase in order to accomplish such intent regardless of whether such inclusion in a code is accomplished, sections of the ordinance may be re-numbered or re-fettered. Typographical errors which do not affect the intent of this ordinance may be authorized by the City without need of public hearing by its filing a corrected or re-codified copy of the same with the City Recorder.

SECTION III. Severability

If any section, phrase, sentence, or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

SECTION IV. Effective Date

The City Recorder shall deposit a copy of this ordinance in the official records of the City on December 29<sup>th</sup> 2023, and before 5:00 p.m. on that same day, shall place a copy of this ordinance in three places within the City. This ordinance shall become effective at 5:00 p.m. on December 29<sup>th</sup>, 2023. The plan will be amended no less than every five years and will continue to play a vital role in the future development of Santaquin City, Utah.
