7. Chamber of Commerce Report

Assistant City Manager Bond presented the Morgan Subdivision Infrastructure Deferral Agreement. The subdivision is located at approximately 95 E. 200 N. Santaquin City Code requires all street improvements (i.e., curb, gutter, sidewalk, landscaping, etc.) to be installed. The proposed subdivision is in the core area of town. There are no street improvements currently located in the area. The applicant, Bill Morgan, attended the meeting. He encouraged the City to look at the contract used for deferral agreements for future applications.

REPORTS BY STAFF, COUNCIL MEMBERS, AND MAYOR OLSON

Assistant Manager Bond reported on upcoming items on Development Review Committee and Planning Commission meeting agendas. Assistant Manager Bond invited council members to the Employee Christmas Party on December 10th. It is unknown whether there will be a council meeting on December 3rd. The Planning Commission meeting set for December 10th will be cancelled.

Manager Beagley reported that the City Office building was busy due to today also being Election Day, with a County voting center downstairs. He invited members of the council to attend the Santaquin Summit meeting on November 12th with State and County legislators to discuss issues in the City. Manager Beagley informed council members that the website and emails will be changed from .org to .gov in the coming weeks. Manager Beagley updated council members on the Main Street construction project as it finishes before the winter season.

Councilor Keel reported on the Spooky Night at the Museum's success.

Councilor Mecham stated that Councilor Adcock will attend the upcoming water board meeting in his stead.

Councilor Siddoway reported on the Spooky Night at the Museum event as well complimenting the museum and Public Work staff for their hard work to make it happen.

Councilor Adcock also complimented the Spooky Night at the Museum event. He inquired about the progress of Les Schwab Tire's construction progress. Assistant Manager Bond indicated that construction timelines will be up to Les Schwab at this point moving forward. Councilor Adcock asked for information or a report on the CUP pipeline. Manager Beagley indicated that a report will come before the council in January after meetings can be held later this year with CUP and the Mayor. Councilor Adcock also inquired about a possible stop sign on 200 North. Manager Beagley indicated that data will be gathered once the Main Street construction project is complete to better understand traffic on that road. He stated that a HAM radio meeting will be held on November 12th in the EOC room. Lastly, he stated that the American Legion will have a dinner in November as well.

Mayor Olson indicated that negotiations are still continuing for lots in the Santaquin Peaks Industrial Park Subdivision. He reported on the success of the city's Trunk or Treat event. Mayor Olson discussed further work on the structural issues at the museum building. He encouraged council members to walk up the canyon while the weather is good. Mayor Olson reported on meetings that will be held leading up to the 2025 legislative session.
