

# **PUBLIC NOTICE**

RE: A concept plan for a proposed 2-lot subdivision located at 1371 West Cedar Pass Drive.

### **HEARING TIME AND LOCATION:**

Notice is hereby given that the Santaquin City Planning Commission will be holding a public hearing at approximately 7:00 P.M. on Tuesday August 10, 2021, the meeting will be held in person and online.

#### THE PROPOSAL:

Peguy Jacques is proposing a 2-lot subdivision located at 1371 West Cedar Pass Drive. The subdivision is located within the Planned Community zone and is subject to the land use regulations of the R-10 Residential zone. This proposal will create two new lots on parcel 65:207:0265 and adjust the side lot line of parcel 65:207:0266. The proposed Plat F will effectively amend the existing Plat C of the Cedar Point at Summit Ridge subdivision.

### **HEARING PURPOSE:**

The hearing is an open meeting in which residents will have the opportunity to voice concerns or ask questions about the proposal. Input received during the public hearing will help the Planning Commission understand potential impacts. If the impacts can be appropriately mitigated, the Planning Commission may recommend conditions to do so. The proposed plan must be approved if the plan complies with Santaquin City Code. This is the only public hearing that will be held on this request.


