#### 5. Bids for Ambulance Purchase

City Manager Reeves and Fire Chief Lind introduced the item:

The purchase/fabrication of a replacement ambulance was previously approved by the Santaguin City Council within the FY2021-2022 Budget in the amount of \$260,000.00. Under state bid, the purchase of a Ford Chassis (from Murdock Ford) was previously approved in the amount of \$51,171.50, leaving a balance of \$208,828.50 for the fabrication of the ambulance box, associated installation costs and equipment. An advertisement was placed for the fabrication and installation of the ambulance box. Two bids were received. However, only one of the bids met the specification outlined within the advertisement (e.g. construction design and lifetime warrantee – see attached). Although the non-gualifying bid was lower (\$154K vs. 163K), the gualifying bid allows for the reuse of the ambulance box from chassis to chassis; thus, saving the city significant capital replacement cost in the future. In addition, the gualifying bid also provides equipment that matches Santaguin City's other ambulance, which will provide more consistent operational use for our staff; thus, lowering training time. It is for these reasons that Chief Lind is recommending that you award the 2021 Ambulance Bid to OSAGE, in an amount of \$162,949.00. This will leave a balance of \$45,879.50 for the remainder of the ambulance's equipment and supplies. [Less the cost of the Power Load (\$22,600) and Power Cot (\$20,548), a remaining balance of \$2,727.50 would be used to stock and logo the ambulance.]

Motion made by Council Member Mecham to award the 2021 Ambulance Bid to OSAGE in an amount of \$162,949.

# 6. Bids for Update of the Parks, Recreation, Trails, Open Space Master Plan

Community Development Director Jason Bond introduced the item:

It is time to update our Parks, Recreation, Trails, and Open Space Master Plan as well as the associated Impact Fee Facility Plan (IFFP) and Impact Fee Analysis (IFA). We have budgeted

for this work in the City's approved 2021-2022 budget. Per the Council's direction, we requested a proposal for this work from Blu Line Designs. Blu Line Designs submitted their proposal to update this master plan and the associated IFFP & IFA. Their proposal is attached for your review. Blu Line's proposed scope and fee for this complete master plan update is \$66,900.00. The proposed amount is in line with our budgeted amount for this project and in line with industry standard costs for this type and scope of work. Having completed our previous master plan update and having designed other city parks facilities projects for us since the last master plan update, Blu Line is very familiar with Santaquin City park facilities, standards, etc. and is therefore well situated to complete this work for us.

Motion made by Council Member Miller to award a contract to Blu Line Designs for updating the Santaquin City Parks, Recreation, Trails, and Open Space Master Plan and the associated IFFP and IFA, in an amount not to exceed \$66,900.00.

#### 7. Public Hearing Regarding Ordinance Amending City Water System Regulations

Motion made by Council Member Miller to enter a formal public hearing for an Ordinance amending city water system regulations.

City Manager Reeves introduced the subject of the public hearing:

Under the authority of Utah Code § 10-8-15, as amended, the city hereby exercises a municipality's extraterritorial jurisdiction to protect its culinary water system and its sources from exposure to underground percolation from any ecological injury, pollution or contamination of the watershed or exposure of the system and water polluting underground percolations influencing the culinary waterworks source. The City, under the authority of Utah Code § 10-8-15, as amended, further declares that all lands (whether inside or outside the incorporated municipal boundaries) within three hundred feet (300') on either side of the transmission or interceptor lines and the inlet facilities of each and all of the collection, interception and inlet facilities of Santaquin City and shall be subject to all culinary water source preservation and protection regulations of Santaquin City.



# 9. Ordinance 10-01-2021 - Utilities Amendment

codification, correction of scrivener's errors, severability, and an effective date for the ordinance.

# 10. Ordinance 10-02-2021 - RC Zone Revised Uses

Community Development Director Jason Bond explained that all of the changes took place in the land use table and the reasonings behind them.

Motion made by Council Member Montoya to adopt Ordinance 10-02-2021 amending Santaquin city code to update the land use table in the residential commercial (RC) zone, providing for codification, correction of scrivener's errors, severability, and an effective date for the ordinance.

# 11. Ordinance 10-03-2021 - Animal Rights Amendment

Community Development Director Jason Bond introduced the item as part of the efforts done by Operations Manager Dennis Marker clean up of code and this whole ordinance has to do with fancier hobby permits that allow for additional dogs or cats without needing a kennel. This code amendment helps clarify what the process is for a fancier hobby permit which is to receive a conditional use permit by the planning commission. This received unanimous support from the planning commission.

Motion made by Council Member Miller to approve Ordinance 10-03-2021 amending animal control regulations, providing for codification, correction of scrivener's errors, severability, and an effective date for the ordinance.

# 12. Ordinance 10-04-2021 - Parking Enforcement on School District Property

City Manager Reeves explained that Nebo School District reached out to the city and asked them to enforce city ordinances on school district property especially in regard to parking on school district property.
