Vice Mayor Thomas stated that we are not a gated community. Yes, our community should stay clean. Do a little tour of the village then have some discussion for community standards that need enforcing. We have a citizen complaint so we need to address the issue, right?

Needs to be kind of loose -not a gated community. Our city needs standards though.

Community Standards Committee - establish one? Asked the City Administrator.

Have further talks about it.
