WHEREAS, the Friends of Uptown Social have historically tracked receipts and expenditures related to certain senior services activities; and

WHEREAS, to remain compliant with debt issuance requirements the City is working with the Friends group to bring the required revenues and expenses into the City's accounting system; and

WHEREAS, to keep the Uptown Social building and programs sufficiently funded, staff is requesting a special revenue fund be created to track these transactions.

NOW, THEREFORE, BE IT RESOLVED: That the Finance Director is hereby authorized and directed to create a Special Revenue Fund for senior services via the following budget amendment:
