Conditional Use Explanation

Dear Mr. Sokolowski,

The intent of this letter is to explain the reason for the Sheboygan Areas School Districts conditional use permit application.

The school district is pursuing the possible upgrade of the North High School outdoor sports field scoreboard. Currently, the scoreboard is solely used for football events. It is our intent to upgrade the existing scoreboard to one that has video capabilities. With the upgrade of video, we will have the flexibility to use it for multiple sports and other events.

The district is working to create curriculum for the students to develop multimedia productions which can be displayed on the video board during school events. This experience can then be used to advance future opportunities in their careers. The addition of video would also be used to increase school spirit while attending the sporting events.

We feel that there will be not be any substantial or undue impact to our neighbors by adding the video board. The new scoreboard will not have sound capabilities. The existing stadium sound system will be utilized as it has been in the past to compliment the video.

Due to the large setback of over 1000' from the houses to our north on Grand Avenue, the video display should not be a disruption to the neighborhood.

The existing scoreboard foundation and framework will be utilized so there will be no location or directional viewing changes involved in this project. The board will only be viewed from the spectator stands and from the north end of the grounds. The new scoreboard will have an aluminum surface with colors to match the North High School theme. The plan is to begin the scoreboard conversion this summer and have it completed before the first football game in August.







Proposed Score Board




Proposed Scoreboard Video Mode








East View
