☒ In addition to the five members above, the mayor shall appoint two alternate members who shall be actively engaged in the contracting business and may be among those identified above or be a state-licensed master electrician, journeyman electrician, or master plumber. The alternate members shall act with full power only when a member of the board refuses or declines to vote, is disqualified because of interest, or when a member is absent. (Updated 11/04/2024).
