


Gen. Ord. No. 5 - 23 - 24. By Alderpersons Dekker and Rust. June 5, 2023.

AN ORDINANCE repealing various ordinances so as to remove the one-way street designation for South 19th Street, South 20th Street, South 21st Street, South 22nd Street, South 23rd Street, and South 24th Street between Indiana Avenue and Georgia Avenue; removing parking on the west side of South 19th Street, South 20th Street, South 21st Street, South 22nd Street, and South 24th Street between Indiana Avenue and Georgia Avenue; and removing parking on the east side of South 23rd Street between Indiana Avenue and Georgia Avenue.

WHEREAS, construction on Indiana Avenue is set to begin shortly, which will cause significant issues with travel on a number of streets south of Indiana Avenue that are currently signed as one-way streets; and

WHEREAS, the streets affected are narrow and will not be able to handle parking on both sides of the street if they are two-way streets; and

WHEREAS, it is anticipated that at some point this ordinance will be able to be repealed and the prior designations set back in place; and

WHEREAS, suspension of the rules is warranted to prevent certain residents from losing access to their homes should the one-way restrictions remain in place.

THE COMMON COUNCIL OF THE CITY OF SHEBOYGAN DO ORDAIN AS FOLLOWS:

Section 1. Gen. Ord. No. 27-72-73, which designated South 19th Street and South 20th Street between Indiana Avenue and Georgia Avenue a one-way street is hereby repealed.

Section 2. Gen. Ord. No. 67-79-80, which designated South 21st Street and South 22nd Street between Indiana Avenue and Georgia Avenue a one-way street is hereby repealed.

Section 3. Gen. Ord. No. 52-75-76, which designated South 24th Street between Indiana Avenue and Georgia Avenue as a one-way street is hereby repealed.

Section 4. Pursuant to Section 118-126 of the Municipal Code entitled "Prohibitions and Restrictions Authorized," the west side of South 19th Street from the south curb line of Indiana Avenue to the north curb line of Georgia Avenue is hereby added to the list of locations where parking is not permitted.

Section 5. Pursuant to Section 118-126 of the Municipal Code entitled "Prohibitions and Restrictions Authorized," the west side of South 20th Street from the south curb line of Indiana Avenue to the north curb line of Georgia Avenue is hereby added to the list of locations where parking is not permitted.

Section 6. Pursuant to Section 118-126 of the Municipal Code entitled "Prohibitions and Restrictions Authorized," the west side of South 21st Street from the south curb line of Indiana Avenue to the north curb line of Georgia Avenue is hereby added to the list of locations where parking is not permitted.

Section 7. Pursuant to Section 118-126 of the Municipal Code entitled "Prohibitions and Restrictions Authorized," the west side of South 22nd Street from the south curb line of Indiana Avenue to the north curb line of Georgia Avenue is hereby added to the list of locations where parking is not permitted.

Section 8. Pursuant to Section 118-126 of the Municipal Code entitled "Prohibitions and Restrictions Authorized," the west side of South 24th Street from the south curb line of Indiana Avenue to the north curb line of Georgia Avenue is hereby added to the list of locations where parking is not permitted.

Section 9. Pursuant to Section 118-126 of the Municipal Code entitled "Prohibitions and Restrictions Authorized," the east side of South 23rd Street from the south curb line of Indiana Avenue to the north curb line of Georgia Avenue is hereby added to the list of locations where parking is not permitted.

Section 10. The Department of Public Works and the Police Department are hereby authorized and directed to install and remove all signs necessary to remove and give notification of the aforementioned traffic regulation.

Section 11. It appearing that the designation of South 23rd Street between Indiana Avenue and Georgia Avenue as a one-way street may never have been properly approved by the Common Council, the Department of Public Works and the Police Department are hereby authorized and directed to remove all signage designating South 23rd Street between Indiana Avenue and Georgia Avenue as a one-way street.

Section 12. All ordinances or parts thereof in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict, and this ordinance shall be in effect from and after its passage and publication.
