Occupancy Permit

Credentialed Inspector Inspections: \$75.00 per occurrence

- Reinspection due to non-compliance
- No Show for scheduled/requested inspection
- No Call for Required Inspection

A property owner who hires an unlicensed contractor shall be responsible for a double permit fee plus \$200.

Except in cases of emergency, when a contractor/owner starts work without first securing a permit, the contractor/owner shall be responsible for double permit fee plus:

- 1st Incident: \$100.00
- 2nd Incident: \$250.00
- 3rd and Subsequent Incidents: \$500.00

**** Notes:**

- No permit is required for minor alterations under \$600.00 of materials or \$1200.00 total materials and labor unless such work requires structural alterations. All fences, railings, steps/stairways, porches/rescue platforms and new concrete require a permit.
- Gross square footage calculations are based on exterior dimensions, including garage and each finished floor level. Unfinished basements or portions thereof are not included.
- In determining costs, all construction should be included with the exception of suspended ceilings, floor/wall coverings, heating, air conditioning, electrical or plumbing work. Costs of project shall be rounded up to the next full dollar amount for permit fee calculations.
- No building permits shall be issued until municipal sewers and water services have been provided adjacent to the building site or when a contract has been let and installation of services are in progress.
- No permits shall be issued if the property owner owes fines/fees to any City of Sheboygan or Sheboygan County agency or department.
- No occupancy shall be allowed until sewer, water, and electrical services to building have been completed.
- Permit fees paid are not refundable.
