

Board of Review will meet on the 22nd day of April, 2024 at 1:00 p.m. at City Hall – 3rd Floor Council Chambers, 828 Center Avenue, for the purpose of calling the Board of Review into session during the hours of 8:00 a.m. until before noon the 4th Monday in April, pursuant to s. 70.47 (1), Wis. Stats.

Due to the fact the assessment roll is not completed at this time, The Board of Review will be adjourned until the 11th day of September, 2024 at 9:00 a.m. Pursuant to s. 70.47 (2), Wis. Stats.:

No person shall be allowed to appear before the Board of Review, to testify to the Board by telephone or to contest the amount of any assessment of real or personal property, unless such person has refused a reasonable written request by certified mail from the assessor to enter onto property to conduct an exterior view of such property being assessed.

After the first meeting of the Board of Review and before the Board's final adjournment, no person who is scheduled to appear before the Board of Review may contact, or provide information to, a member of the Board about that person's objection except at a session of the Board.

No person may appear before the Board of Review, testify to the Board by telephone or contest the amount of any assessment unless, at least 48 hours before the first meeting of the Board or at least 48 hours before the objection is heard, the person has filed, under s. 70.45, sub. (3) (a), that person provides to the clerk of the Board of Review notice as to whether the person will ask for removal under s. 70.45 (a) and "so" which member will be removed. If the person's reasonable estimate of the length of time that the hearing will take.

When appearing before the Board, the person shall state the name of the person's estimate of the value of the land and of the improvements that are the subject of the person's objection and specify the information that the person used in arriving at that estimate.

No person may appear before the Board of Review, testify to the Board by telephone or object to a valuation; if that valuation was made by the assessor or the assessor's employee, unless, unless the person supplies to the assessor all of the information about income and expenses, as specified in the manual under s. 70.35 (2a), that the assessor requests. The municipality or county shall provide by ordinance for the confidentiality of information about income and expenses that is provided to the assessor under this paragraph and shall provide exceptions for persons using the information in the discharge of duties imposed by law or of the duties of their office or by order of a court. The information that is supplied under this paragraph, unless a court determines that it is inaccurate, is not subject to the right of inspection and copying under s. 19.35 (1).

Pursuant to s. 70.45, Wis. Stats. the assessment roll for the Year 2024 assessment will be open for examination starting July 29, 2024 through August 2, 2024 from 8:30 a.m. – 4:00 p.m.
