

Res. No. 32 - 23 - 24. By Alderpersons Mitchell and Filicky-Peneski. July 17, 2023.

A RESOLUTION authorizing the appropriate City officials to execute the documents necessary to purchase an ambulance from Pomasl Fire Equipment, Inc. for the Sheboygan Fire Department and to make other purchases necessary to equip the new ambulance.

WHEREAS, it is in the City's best interest to have a functioning ambulance fleet for emergency response; and

WHEREAS, the Fire Department's previous ambulance orders have seen extensive delays such that orders placed in 2021 and 2022 are not being delivered until late 2024 and 2025 respectively; and

WHEREAS, the Fire Department's current ambulances need significant repairs and continue to be placed out of service for extended periods of time; and

WHEREAS, an ambulance is currently available to be delivered in March of 2024 through the vendor Pomasl Fire Equipment Inc., which will improve the department's operations and reduce downtime; and

WHEREAS, ordering an ambulance from any other vendor would delay delivery until 2026; and

WHEREAS, the ambulance from POMASL is equivalent to what the Fire Department currently operates and will meet the department needs; and

WHEREAS, the City's 2023 - 2027 Capital Improvement Program had an ambulance purchase scheduled for 2024; and

WHEREAS, there is sufficient fund balance to pay for the down payment and purchase of the ambulance.

NOW, THEREFORE, BE IT RESOLVED: That the appropriate City officials are hereby authorized to draw funds in the amount of \$351,806.36, for the purchase of the ambulance and other equipment necessary to equip the ambulance, from Account No. 400200-651100 (Capital Projects - Public Safety - Vehicles).

BE IT FURTHER RESOLVED: That the Finance Director is authorized to make the following budget amendment in the 2023 budget to allow for the required

# Pomasl Fire Upgrades and Installs:

The following are optional upgrades or changes. These would be in addition to the pricing above.

- 1. Supply and install (2) slide out drawers on the curbside interior. The drawers would be recessed into the C3 exterior compartment. The drawer assembly would be fully enclosed in the C3 exterior compartment. There would be room under the drawers for a stair chair or other. See attached pictures. We have installed this on (4) ambulances for customers. ALS & paramedic services like these drawers.
- 2. Dual Buell Air Horns: supply and install dual Buell air horns with compressor, air lines, air tank, compressor cover, etc.
- 3. Pomasl Fire will install a customer supplied dual head mobile radio. Pomasl Fire will supply face plates so the remote heads can be flush mounted in the console and the patient area.
- 4. Ferno INTRAX mounting brackets:
  - a. Lifepak 15 defib wall mount bracket
  - b. Double pole mount
  - c. Tablet mount
  - d. Sharps bin mount with sharps container
