#### **Position Summary:**

The Marina Maintenance Manager is responsible for overall operation and maintenance of Marina docks, buildings, and grounds. The Marina Maintenance Manager participates in the hiring, training, and scheduling of seasonal employees. The Marina Maintenance Manager provides excellent customer service as needed.

#### **Essential Responsibilities:**

- Oversees the mooring and hookup of vessels within the facility
- Inspects and maintains facility, equipment, etc., to ensure safety and proper functionality
- Responsible for Spring preparations including but not limited to:
  - o Inspects dock systems for safety and repairs damages found.
  - Reconnects fuel dock to sea-wall and ensure pumps, waterlines, etc., are functioning correctly
  - Ensures electrical and water supplies are operational or coordinates services from electrician or plumber
  - o Reopens access to main building, bathrooms, and shower area
- Operational season responsibilities including but are not limited to:
  - o Maintains facility structures and making repairs as needed
  - o Assists boaters with requests or problems
  - o Monitors water levels and adjusts chains as needed
  - o Supervises, schedules, and supports seasonal staff
  - o Maintains cleanliness of the Marina facility, including bathrooms and showers
  - o Inspects fuel dock monthly and upkeeps maintenance
- Responsible for Fall preparations including but not limited to:
  - o Blows out water lines with compressor
  - Turns off electric supply
  - Prepares docks for winter storage
  - Winterizes buildings, fueling dock, and grounds
- Off Season responsibilities including but are not limited to:
  - Replaces damaged parts/pieces in preparation for Spring
  - Clears snow from walk areas, fire hydrants, parking area, etc.
  - Assesses and makes purchases for upcoming operational season
  - o Other Public Works duties as assigned
- All other duties as assigned
