**CITY OF SHEBOYGAN
GENERAL ORDINANCE 12-23-24**

JULY 17, 2023.

AN ORDINANCE re-establishing the salaries of Election Officials.

WHEREAS, Election Officials received a salary increase in early 2023, however, the Finance and Personnel Committee also requested that a new Ordinance change with an increase be submitted prior to the 2024 budget completion; and

WHEREAS, full-time Election Officials are not allowed to leave the premises on Election Day; and

WHEREAS, full-time Election Officials currently work approximately 14-16 hours on an election day, and part-time Election Officials currently work approximately 7-9 hours on an election day; and

WHEREAS, Wis. Stat. § 7.03 requires that a reasonable daily compensation be paid to each inspector; and

WHEREAS, current Election Official pay in the City of Sheboygan remains one of the lowest in the county; and

WHEREAS, average Election Official pay in the other communities in Sheboygan County is just under \$180.00 for a full day and \$90.00 for a half day (i.e., just under \$12.00 per hour), and just under \$212.00 for chief inspectors (chairpersons), excluding the benefits some communities provide; and

WHEREAS, it is becoming increasingly difficult to find and keep qualified and competent inspectors.

THEREFORE, THE COMMON COUNCIL OF THE CITY OF SHEBOYGAN DO ORDAIN AS FOLLOWS:

SECTION 1: **AMENDMENT** The Election Officials appointed to perform election duties in the various wards of the City of Sheboygan shall be paid in accordance with the following schedule:

\$ 90.00 for half of Election Day
\$180.00 for full Election Day
\$210.00 for co-chairpersons
\$ 10.00 per hour for attending instructional meeting
\$ 10.00 per hour for special nursing home deputies.

SECTION 2: REPEALER CLAUSE All ordinances or resolutions or parts thereof in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict.

SECTION 3: EFFECTIVE DATE This Ordinance shall be in effect from and after its passage and publication according to law.
