## EXTENSION OF CONTRACT

THIS EXTENSION OF CONTRACT (this "Extension") is made and entered into this 2 day of June, 2025 by and between WASTE INDUSTRIES, LLC, a limited liability company doing business in Brunswick County, North Carolina, as GFL Environmental (the "Contractor") and the TOWN OF SHALLOTTE, a municipal corporation under the laws of the State of North Carolina (the "Town"), located in Brunswick County, North Carolina.

### RECITALS:

- A. Contractor and the Town are parties to a contract dated September 30, 1999, as previously amended and extended (the "Contract"), for provision of curbside recycling collection in The Town of Shallotte, North Carolina.
- B. The parties desire to extend the term of the Contract set forth herein.

### AGREEMENT:

Now, therefore, in consideration of the Recitals and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree that:

The term of the Contract shall be extended for the one-year period from July 1, 2025 through June 30, 2026.

Except as modified above, all other terms and conditions of the Contract shall remain in full force and effect.
