Dear Mayor Eccard,

Please see the attached items for your information and use relating to the proposed speed limit reduction on the SR 1949 parts of Brierwood Road just northwest of SR 1943 Country Club Drive. Based on concerns expressed by the police chief and a local resident, the Department plans to lower the speed limit from 35 mph to 25 on its 0.28-mile-long section. The town has annexed short sections of the right-of-way at each end, so action by the Board of Aldermen is required to effect the change on those two short sections which are inside the town limits.

We plan to: REPEAL Rural Speed Limit 35 Ordinance #1061794 of 12/23/2010 for the 0.280-mile DOT section of the street: (Brierwood Road SW) from 0.28 mile west of SR 1943 (Country Club Road SW) to SR 1943. (Mile Post 0.000 to 0.280 Length = 0.280 mile or 1,478.4 feet). No town action is required.


ENACT Rural Speed Limit 25 Ordinance #1087289: (Brierwood Road SW) between 0.043 mile northwest of SR 1943 (Country Club Drive SW) and 0.251 mile northwest of SR 1943. (MP 0.043 to 0.251. L = 0.208 mile or 1,098 feet.) No town action is required.

ENACT Municipal Speed Limit 25 ordinance #1087290: (Brierwood Road SW) between SR 1943 (Country Club Drive SW) and 0.043 mile northwest of SR 1943. (MP 0.000 to 0.043 L = 0.043 mile or 227 feet.)

ENACT Municipal Speed Limit 25 ordinance #1087292 between 0.251 mile northwest of SR 1943 (Country Club Drive SW) and End of Maintenance at 0.280 mile northwest of SR 1943. (MP 0.251 to 0.280 L = 0.029 mile or 153 feet.)

Concurrence by the town is required for the last two items. Attached/enclosed are two advance informational or final Municipal Certification Declaration forms, plus two spare forms, for enactment of the two short municipal ordinances. Please put the matter on the Board's meeting agenda for adoption of a resolution. The required original forms on watermarked bond paper are being USPS-mailed to you and there can be no annotations, changes, or corrections made on the original forms. After adoption by the Board, the two original forms should then be certified by the city clerk or by the mayor and sent by US mail to my attention at the below address. No action by the town is needed for the rural ordinances. Please let us know if you have any questions.
