Re: RICHLAND COUNTY GROWTH POLICY; SIDNEY GROWTH POLICY; FAIRVIEW GROWTH POLICY; RICHLAND COUNTY ZONING FEASIBILITY STUDY

Purpose of the Memo

This memo serves to provide an overview of the upcoming Richland County Zoning Feasibility Study and Growth Policy for Richland County, Fairview and Sidney, which is based on Montana Code Annotated (MCA) 76-1-601. The Growth Policy outlines the county's vision for development, land use, and infrastructure, ensuring sustainable and strategic growth in alignment with the needs of the community. The zoning feasibility study will be occurring simultaneously.

Background

As required under MCA 76-1-601, local governments in Montana are authorized to prepare and adopt a Growth Policy. While not a regulatory document, the Growth Policy guides decision-making processes related to land use, subdivision review, public services, and other planning-related matters. The policy is instrumental in aligning the community's goals with legal and procedural frameworks.

Funding

The Growth Policy is being partially funded by the Community Development Block Grant program (CDBG) for \$50,000 as reimbursement to the County. The local match is being met by Richland County contributing \$38,000. The City of Sidney and Town of Fairview have also stated that they will be financially participating.


