RESOLUTION

CITY OF SANDPOINT

TITLE: APPROVING PO #25-1532 TO FREIGHTLINER NORTHWEST FOR MY26 FREIGHTLINER 114SD DUMP TRUCK

WHEREAS: City staff recommends the purchase of a new MY26 Freightliner 114SD 6-yard dump truck to replace the City's current 1993 Ford L900 12-yard dump truck, as provided within the FY26 Budget;

WHEREAS: This vehicle will support essential utility operations, shared between the Water Distribution and Wastewater Collection Divisions and used to haul the Utilities Division's John Deer Mini 50 Excavator to job sites, with the smaller size of the new dump truck allowing crews to easily work in residential areas and improving maneuverability and efficiency during maintenance, repair, and replacement of Sandpoint's aging water and sewer infrastructure;

WHEREAS: It was determined that, while there may be a lower upfront cost for a used truck, the new vehicle will offer better long-term value through improved reliability, safety, and lower maintenance costs, with full warranties included, reducing downtime and allowing staff to maintain consistent core functions and an anticipation that this new vehicle will require fewer repairs and hold higher resale value, where the City's in-house mechanic is equipped to service the truck, reducing dependence on outside vendors;

WHEREAS: The additional benefit of a new truck is that it meets current emissions and safety standards, including EPA Tier 4 compliance and modern features like backup cameras and improved ergonomics, supporting both operator safety and regulatory compliance;

WHEREAS: The truck will be purchased through a Sourcewell Cooperative Contract – Contract No. 032824-DAI, as allowed by Idaho Code § 67-2807 – Cooperative Purchasing; and

WHEREAS: The 1993 truck, with approximately 112,575 miles, has exceeded its useful life due to age and high maintenance and repair costs and will be auctioned following Council's declaration of surplus.

NOW, THEREFORE, BE IT RESOLVED THAT: City of Sandpoint Purchase Order #25-1532 is hereby awarded to Freightliner Northwest in the amount of \$231,800.28 for the purchase of a MY26 Freightliner 114SD 6-yard dump truck.

BE IT FURTHER RESOLVED THAT: As set forth in the Procurement Process and Signature Authority Policy for Goods, Services, and Construction and further outlined in the City of Sandpoint Procurement Policy, on behalf of the City, the Mayor or authorized designee is hereby permitted to execute the documents necessary to effect this purchase.
