SUBJECT: PO 25-1532 – Freightliner Northwest for MY26 Freightliner 114SD Dump Truck

DESCRIPTION/BACKGROUND:

The new 2025 Freightliner 114SD 6-yard Dump truck is to replace the current 1993 Ford L900 12-yard dump truck. This vehicle will be shared between the Water Distribution and Wastewater Collection Divisions and will be used to haul the Utilities Division's John Deer Mini 50 Excavator to job sites. The smaller size of the new dump truck will be beneficial for crews working in residential areas, improving maneuverability and efficiency during maintenance, repair, and replacement of Sandpoint's aging water and sewer infrastructure.

Staff recommends the purchase of a new dump truck to support essential utility operations. Used equipment was explored and while there are lower upfront cost, the new vehicle offers better long-term value through improved reliability, safety, and lower maintenance costs. The new dump truck will come with full warranties, reducing downtime and allowing us to maintain consistent core functions. In addition, we anticipate that this new vehicle will require fewer repairs and hold higher resale value. Our in-house mechanic is equipped to service this truck, reducing dependence on outside vendors and helping us keep the fleet operational and cost-effective.

This new dump truck also meets current emissions and safety standards, including EPA Tier 4 compliance and modern features like backup cameras and improved ergonomics. This supports both operator safety and regulatory compliance.

This Freightliner Dump Truck will be purchased through a Sourcewell Cooperative Contract No. 032824-DAI as allowed per Idaho Code §67-2807 – Cooperative Purchasing.

The 1993 Ford L900 12yd dump truck currently has approximately 112,575 miles on it. This truck will be auctioned on Public Surplus after it is declared surplus. This truck has exceeded its useful life due to age and the high maintenance and repair costs.

STAFF RECOMMENDATION:

Staff recommends City Council consider approval of Purchase Order No. 25-1532 to Freightliner Northwest for MY26 Freightliner 114SD Dump Truck in the amount of \$231,800.28.
