2. Discuss and Adopt Definition of Sustainability

The Committee discussed the definition of sustainability, as noted and provided by a variety of sources, and ultimately agreed to adopt the following definition for the purpose of their work and focus: "Sustainability: Meeting the needs of the present without compromising the ability of future generations to meet their own needs. Sustainability has three dimensions: environmental, economic, and social."

3. Discuss Committee's Main Focus, Vision, Goals, and Objectives

Following a discussion, the Committee agreed that the Committee should, in general, support the City in incorporating sustainability into consideration of planning and operations, with an agreement to include this topic on the next meeting agenda for further discussion, creation of a short sustainability checklist that could be used in this regard, and to take action to come to a final consensus and vote on these components.

The Committee members were also encouraged to return to the next meeting, each with a list of their own individual vision for goals that the Committee could endeavor to meet.

4. Discuss Sandpoint Forward Project / Grant Opportunity

It was clarified that there actually is no grant opportunity associated with this topic, as a grant has already been awarded, and that the information regarding the Sandpoint Forward program is simply being provided as informational, where individuals have the option of joining as a volunteer member of the advisory group and participating if they would like, with possible future informational reports to the Committee.
