

CITY COUNCIL MEETING MINUTES

March 19, 2025 at 5:30 PM

Call to Order

Mayor Jeremy Grimm called the regular meeting of the Sandpoint City Council to order at 5:30 p.m. on Wednesday, March 19, 2025, in Council chambers at City Hall, 1123 W. Lake St., Sandpoint, Idaho.

Mayor Grimm led all present in the Pledge of Allegiance.

Announcements and Reports

- 1. Mayor Grimm proclaimed April 2025 as Strengthening Families to Prevent Child Abuse Month in the City of Sandpoint.
- 2. Mayor Grimm proclaimed April 14-18, 2025, as Live Give 7B Week in the City of Sandpoint.
- 3. Following a brief introduction by Finance Director Sarah Lynds, Laura Parasida with Magnuson, McHugh, Dougherty, CPA, reviewed the City's audited financial statements for the fiscal year ending September 30, 2024. Information only; no Council action.
- 4. No Council comments or questions regarding the FY2024 4th Qtr. Financial Report, provided in the meeting packet.

Mayor Grimm noted a local newspaper article that reported area cities are still showing growth, even as growth across the State of Idaho appears to have slowed and remarked on the current vacancy rate at a local apartment complex. He provided an update on proposed legislation currently before the Idaho Legislature regarding local regulation of short-term/vacation rental homes. He remarked that, as it has been several months now since the City's citizen advisory boards were revived and have been meeting regularly, he is conducting a review of these boards and their operations. He further reported on ongoing concerns regarding the City's wastewater treatment plant.

Council members provided reports from recent meetings of the citizen advisory boards on which they serve as Council liaison.

At the invitation of the Mayor, Department Directors provided reports on projects and activities in their respective departments.
