### SUMMARY

The purpose of this Agenda Bill is to approve the Mayor's recommendation to appointments and re-appointments on the Economic Development Commission, Lodging Tax Advisory Committee, and Planning Commission.

Nick Postiglione has applied to fill position #7 on the Economic Development Commission which will be vacant as of January 1, 2025. His term will expire December 31, 2026. Nick has lived in the city for 3 years and operates a business within the Snoqualmie business community. He will make a great addition to the Economic Development Commission.

Nichole Pas is a current Economic Development Commissioner, filling position #5, and wishes to continue her service. Her term will expire December 31, 2026.

Laurie Hay (position #2), Richard Anderson (position #3), and Kelly Coughlin (position #4) are current members of the Lodging Tax Advisory Committee and wish to continue their service. Their terms will expire December 31, 2025.

Luke Marusiak has been a Planning Commissioner since 2017, filling position #5, and wishes to continue his service. His term will expire 12/31/2028.

## **BACKGROUND**

Staff reached out to current members with expiring terms to determine interest in re-appointment. The individuals being re-appointed here have requested re-appointment.

Following these appointments, the Arts Commission will have three open positions, the Economic Development Commission will have one open position, and the Parks & Events Commission will have three open positions. Recruitment to fill these positions is ongoing.

## **APPOINTMENT PROCESS**

Commission and Advisory Committee members are appointed by the Mayor and subject to confirmation by the City Council as outlined in Title 2 of the Snoqualmie Municipal Code.
