- 4. Community Center Update and CIP Funding Strategy. Presentation by Jeff Hamlin, Parks & Public Works Director and Drew Bouta, Finance Director. Handout provided of Absher Full & Reduced Program Construction Cost Estimates dated April 19, 2024. Topics included progress of the project, recent activities including fundraising and price reduction measures, phased approaches, Phase I and Phase 2 Developments, estimated cost summary for full program and phased approach, CIP and the Community Center background, the four financial buckets, community survey results, planning efforts, 2023-2028 CIP Worksheet, 2025-2030 CIP Worksheet, one-time sales tax and real estate excise tax, interim financing, bonding, and debt service, capital program and debt service sustainability, other options, amount spent and construction cost inflation, and community center benefits. Council comments and questions answered by Director Bouta throughout the presentation.
- 5. Public Financing and Municipal Bonds. Presentation by Thomas Toepfer, Managing Director, of PFM Financial Advisors. Topics included an introduction to debt financing, types of general obligation debt, debt rating, how credit quality affects borrowing costs, debt capacity, interim financing, line of credit considerations, local government rating calculator, comparable cities, market updates including recent AAA BVAL yield curve movement, municipal market supply & demand, and historical and forecasted interest rates. Council questions answered throughout the presentation.
