<b>Background/Overview *</b>

On December 8, 2025, Council approved [Resolution 1729](#) amending the Financial Management Policy. Staff were directed to prepare an ordinance amending and repealing SMC to align with that amended policy. The attached and proposed ordinance accomplishes this.
