The purpose of this ordinance is to amend the 2025-2026 Biennial Budget to provide the City with the appropriation necessary to account for the dissolution of the North Bend Police Services Agreement, the

adoption of the Utility Rate Study, City expenditures rising at a pace greater than inflation, project amendments, and other various expenditures throughout the City.

Proposed Motion

This is the first reading of Ordinance 1309. The second reading and proposed adoption is scheduled for the November 24, 2025 City Council meeting.

Background/Overview*

The 2025-2026 Biennial Budget was adopted by Ordinance No. 1296 on October **3**, **2024**. Administration is requesting a net reduction in appropriation of \$16,139,143. The adjustment will also include a reduction of revenue totaling \$19,764,836.
