#### Background/Overview\*

What was done (legislative history, previous actions, ability to hyperlink)

In February of 2025 a competitive RFQ was conducted to select a consultant to assist the City in preparing a strategic plan. All submissions were reviewed and scored by team comprised of members of the City Council, Administration, and staff. The top three scorers were then invited to an interview. At the conclusion of the selection process, Berk Consulting of Seattle was selected.

Through an interactive process, Berk Consulting has conducted general public outreach, targeted partner outreach, and public meetings to assist the City Council in identifying the publics priorities. Most recently, Berk has conducted several workshops with the City Council to assist in developing the plan.

#### Analysis\*

The draft 2025 Strategic Plan identifies three priorities to focus the organization on for the next five years. These priorities: I. Invest in a trusted community relationship, II. Provide responsive fiscally responsible City services, III. Proactively increase housing options and economic vitality; have been identified by the community and City Council as the most important. These priorities will guide budgeting and resource allocation decisions for the period that the Strategic Plan is current (approximately the next 5 years). The Strategic plan includes a draft implementation program and assigns monitoring responsibilities for the sections. The Strategic Plan ensures accountability by requiring quarterly progress reports for the City Council. Finally, when adopted, the agenda bill process will be modified to include a section identifying which section of the Strategic Plan the item for consideration meets.

#### **Budgetary Status\***
