This meeting was conducted in person at Snoqualmie City Hall and remotely using Zoom.

CALL TO ORDER – CM Cotton called the meeting to order at 5:02 pm.

Committee Members: Councilmembers Bryan Holloway and Catherine Cotton were present. It was moved by CM Holloway to excuse CM Benson, which passed unanimously.
