## A RESOLUTION OF THE CITY COUNCIL OF CITY OF SNOQUALMIE, WASHINGTON AWARDING A CONTRACT FOR CITY SERVER REPLACMENT TO IVOXY CONSULTANTS, LLC

**WHEREAS**, pursuant to Ordinance No. 448 as codified in Snoqualmie Municipal Code Section 1.08.010, the City of Snoqualmie has adopted the classification of non-charter code city, retaining the mayor-council plan of government as provided for in Chapter 35A.12 RCW; and

**WHEREAS**, pursuant to RCW 39.34.030 and guidance from the Office of the Washington State Auditor, local government agencies may use another public agency's active contract for purchases of products, services or public works as long as the "awarding agency" follows its own bid requirements and posts the bid or solicitation notice on a website for purposes of public notice; and

**WHEREAS**, Snoqualmie Municipal Code Section 2.90.020 allows the purchase of materials, supplies and equipment (including capital equipment) through a purchasing cooperative; and

**WHEREAS**, the Washington State Department of Enterprise Services ("DES") is a public agency purchasing cooperative that provides centralized procurement services to its members, including the City of Snoqualmie; and

**WHEREAS**, on April 27, 2022, City staff requested proposals for the Riverview Park Playground Replacement Project from vendors that had been awarded contracts by the KCDA purchasing cooperative; and

**WHEREAS**, the Information Technology Department selected IVOXY Consultin, LLC as the preferred vendor; and

**WHEREAS**, the DES purchasing cooperative has a contract with NetAPP for Computer Equipment awarded in response to Contract #05815 for the term October 1, 2015 through July 31, 2023; and

**WHEREAS**, the DES followed all procurement requirements in issuing Contract #05815 and posted the contract on its website for purpose of public notice; and

**WHEREAS**, the City Council of the City of Snoqualmie has determined that it is in the interest of the City and its residents to use the DES contract with IVOXY Consulting, LLC for the City Server Replacement Project,

**NOW, THEREFORE, BE IT HEREBY RESOLVED** by the City Council of the City of Snoqualmie, Washington as follows:

<u>Section 1</u> . The purchase order contract for the City Server Replacement Project is awarded to IVOXY Consulting, LLC.	
<b>Section 2</b> . The Mayor is authorized to execute a purchase order in the amount of \$70,334.34 with IVOXY Consulting, LLC.
