#### **CALL TO ORDER**

Commission Chair Sweum called the meeting to order at 7:00 pm.

Commission Members: Chair Paul Sweum, and Commissioners Ryan Pryor (remote) and Scott Vermeulen.

Co-Chair Heather Palmerini requested an excused absence which was approved.

**AGENDA APPROVAL:** Commissioner Vermeulen moved and Commissioner Pryor seconded the motion to approve the agenda which passed unanimously.

**COUNCIL LIAISON REPORT –** None. Councilmember Benson was not present.

**MINUTES** – Commissioner Vermeulen moved and Commissioner Pryor seconded the motion to approve the minutes from the March 20, 2023, meeting which passed unanimously.

#### **REGULAR BUSINESS**

- 1. Bylaws Finalization: Brief discussion. It was agreed that the section that reads "No member shall serve more than two (2) consecutive elected terms as Chair" begins this year. Commissioner Vermeulen moved and Commissioner Pryor seconded the motion to approve the Bylaws as stated which passed unanimously.
- 2. Commission Purpose and Direction Discussion: The purpose of the discussion was for the commissioners to express the "why" of their interest and participation in the Parks & Events Commission. Each commissioner had an opportunity to speak. Discussion followed with Mike Chambless providing updates on parks, staffing, and consultants. Public meetings will be held for the community center, comp plan, and trail system. The pool project is rapidly coming forward with the schedule anticipated at the next meeting and improving trail signage is also forthcoming. He informed the Commission that Council approved the next phase of the Riverwalk project.

### **SPECIAL EVENTS UPDATE**

Community Liaison Nicole Wiebe provided an update on the recent Easter egg hunts noting there were over 100 kids present. The Arts Commission is having four different elk murals in the window at Carousel Gifts on Railroad Avenue. She spoke to this Thursday's Volunteer Recognition Event at Snoqualmie Inn from 5:30-7:30 pm.
