The proposed 2025-2026 Biennial Budget was provided as a handout. Presentation provided by Finance Director Drew Bouta and included the 2025-2026 biennial budget executive summary, council priorities, budget process, budget document, the four financial buckets, fund structure, fund summary, biennial budget comparison, position summary, position highlights, other highlights, financial highlights, balanced budget, key

uncertainties, and next steps. Discussion followed. Council questions and comments were made throughout the presentation. Chief Lynch and Chief Bailey provided additional information during position highlights.
