**CALL TO ORDER & ROLL CALL:** Chair Testman called the meeting to order at 7:08 pm.

2. Critical Areas Ordinance – Director Davis started the discussion on the Critical Areas Ordinance. Consultant Jeff Gray from Otak joined the conversation. Jeff Gray went over the best available science with the Commission. Commission members followed the discussion with questions for Director Davis and Jeff Gray regarding the Critical Areas Ordinance and Best Available Science review. CM Johnson joined the conversation and provided clarifying information regarding the Best Available Science review and had questions of his own for Director Davis and Jeff Gray.

It was moved by Commissioner Marusiak to approve the Critical Areas Ordinance and increase the critical area to 500 square feet. With no second, the motion did not move forward.

Further discussion regarding the Critical Areas Ordinance followed.

It was moved by Commissioner Marusiak to approve the Critical Areas Ordinance and increase the buffer zone to 500 square feet. Seconded by Commissioner Hurley, and passed unanimously

**DEPARTMENT REPORT** – Director Davis provided an update to the Commission Members about projects and what the department is focused on.
